WAIVER, RELEASE OF LIABILITY AND IDEMNITY AGREEMENT**

In consideration of Participant being permitted to participate in any way, including travel to and from, in the judo programs and related events and activities of the Manoa Judo Club, the Manoa Japanese Language School, the 50th State Judo Association, or the United States Judo Federation, the undersigned, for myself, heirs, personal representatives and assigns:

1. Agree that prior to participating, the Participant will inspect the facilities, equipment, and rules to be used, and if Participant believes anything is unsafe or beyond Participant's capability, the Participant will immediately advise Participant's coach or supervisor, a representative of Manoa Judo Club, and/or an official of such condition(s) and refuse to participate.

2. Acknowledge and fully understand that judo is a physical contact sport and that the undersigned will be engaging in activities that might result in serious injury, including permanent disability and death, and severe social and economic losses resulting not only from the undersigned's own actions, inactions, or negligence but also the actions, inactions, or negligence of others, the rules of the sport of judo, or the conditions of the facilities or equipment used. The undersigned further acknowledge that there may be other risks not now known or reasonably foreseeable at this time.

3. Assume all of the risks involved in the sport of judo (including but not limited to bruises, scrapes, strained, sprained or torn muscles, tendons or ligaments, broken bones, dislocation of joints, concussion, brain damage, nerve and spinal cord injury, paralysis and death) and accept personal responsibility for any damages for an injury, permanent disability or death.

4. Certify that the undersigned is in good physical condition and has no disease, injury or condition that would impair the undersigned's ability to participate in practice, training or competition.

5. Release, waive, discharge, covenant not to sue, and agree to defend, indemnify and hold harmless Manoa Judo Club, Manoa Japanese School, 50th State Judo Association, and United States Judo Federation, their respective directors, officers, administrators, agents, coaches, instructors, and other volunteers or representatives of those organizations, event officials, medical personnel, other participants, their parents, guardians, supervisors, coaches, sponsors, advertisers, and owners, lessors, lessees of any premises used to conduct events, all of whom are hereinafter referred to as "Releasees", from any and all liability to the undersigned for any and all claims, demands, losses, or damages on account of any injury, including permanent disability or death, or any damage to property caused or alleged to be caused in whole or in part by the negligence of Releasees or otherwise to the fullest extent permitted by law.

I HAVE READ THE ABOVE WAIVER, RELEASE AND IDEMNITY AGREEMENT, UNDERSTAND THAT I GIVE UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND KNOWING THIS SIGN IT VOLUNTARILY. I AGREE TO PARTICIPATE KNOWING AND UNDERSTANDING THE RISKS AND CONDITIONS INVOLVED AND DO SO ENTIRELY OF MY OWN FREE WILL. I AFFIRM THAT I AM AT LEAST 18 YEARS OF AGE, OR, IF I AM UNDER 18 YEARS OF AGE, I HAVE OBTAINED THE REQUIRED CONSENT OF MY PARENT/GUARDIAN AS EVIDENCED BY THEIR SIGNATURE BELOW.
